MUNICIPAL ORDINANCE NO. 21-45

AN ORDINANCE RECLASSIFYING LOT TITLE NO. 59714 SITUATED AT BARANGAY OBAY, POLANCO, ZAMBOANGA DEL NORTE, FROM AGRICULTURAL TO RESIDENTIAL, WHICH ARE SUBJECTS OF PABAHAY PROGRAM FOR SOCIAL HOUSING.

SECTION 1. – Short Title – This ordinance shall be known as the “Reclassification ordinance of particular/specific lands, from agricultural to residential, in the Municipality of Polanco, Zamboanga del Norte”.

SECTION 2. Scope – This ordinance covers specifically Lot Title No. 59714 situated at Barangay Obay, Polanco, Zamboanga del Norte, from agricultural to residential, which are subjects of Pabahay Program for Social Housing.

SECTION 3. Authority

- (1) Article III, Sec. 447, Paragraph 2 (viii), of Republic Act 7160, otherwise known as, the Local Government Code of 1991.
- (2) Rule VII, Article 38, paragraph (a) and (b) No. 2, of the Rules and Regulations implementing the Local Government Code of 1991.

SECTION 4. Limitation – Reclassified lands above-mentioned shall be used solely for the purpose intended as stated in this ordinance.

SECTION 5. Declaration of Intent to Conform with Law - This ordinance is subject to national laws, rules and regulations governing its subject matter.

SECTION 2. PROJECT FOR FUNDING. Purchase of Heavy Equipment for Sanitary Landfill.

SECTION 3. TERMS SHEET. The terms and conditions covering the loan herein authorized are indicated in the Notice of Loan Approval dated February 16, 2021.

SECTION 4. CONFIRMATION, APPROVAL AND RATIFICATION. All of the previous representations, acts, warranties, and all terms and conditions of the Terms Loan as indicated in the Notice of Loan Approval dated February 16, 2021, are hereby confirmed, approved and ratified.

SECTION 5. ENTRY IN THE BOOK OF ACCOUNTS. The Municipal Treasurer and the Municipal Accountant are hereby directed to enter the aforesaid loan in the appropriate books of the Municipal Government.

SECTION 6. DEPOSITORY BANK. The Land Bank of the Philippines is hereby designated as the depository bank of the Local Government Unit (LGU) of Polanco for the Internal Revenue Allotment (IRA) and major depository bank of other deposits, revenues, and collections which designation shall not be revoked while the loan obligation subsists.


SECTION 7. ANNUAL BUDGETARY ALLOCATIONS. The amount for loan repayment shall be appropriated in the annual budget of the Municipal Government until the loan, interest, and other charges are fully paid; including the required LGU equity; the repair and maintenance of the project; the amount for insurance premium and other statutory and contractual obligations.

SECTION 8. AUTHORITY TO DEDUCT. The Land Bank of the Philippines is hereby authorized to intercept for set-off and/or deduct amounts from the general funds of the Municipal Government, and apply the same to the payment of loan or any portion thereof, or interest and penalties thereon as may be deemed necessary.



SECTION 10. EFFECTIVITY. This ordinance shall take effect upon its approval


