MUNICIPAL ORDINANCE NO. 21-46

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 20-34 “AN ORDINANCE PROHIBITING ANY PERSON FROM COMMITTING ANY ACT OF DISCRIMINATION OR ACT WHICH CAUSES STIGMA, DISGRACE, SHAME, HUMILIATION OR HARASSMENT AGAINST HEALTHCARE WORKERS, FRONTLINERS, SOCIAL WORKERS, OFW’S, PERSONS WITH COVID-19 CASES, WHETHER CONFIRMED, PROBABLE OR SUSPECT, RECOVERED OR UNDERGOING TREATMENT, AS WELL AS THOSE PERSONS FORMERLY OR CURRENTLY IDENTIFIED AS PATIENTS UNDER INVESTIGATION (PUI) AND PERSON UNDER MONITORING (PUM) AND IMPOSING SANCTIONS AND PENALTIES THEREOF,” PARTICULARLY SECTION 4, PAR. (A).

Be it ordained by the Sangguniang Bayan of Polanco, Zamboanga del Norte, in a session assembled, that:

SECTION I. – Section 4, paragraph (a) is hereby amended as follows:

a. First Offense – Two Hundred Pesos (P200.00).

SECTION II. All ordinances, rules and regulations or parts thereof, in conflict or inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION III. – This Ordinance shall take effect upon its approval.

Carried unanimously.





SECTION 8. Effectivity – This Ordinance shall take effect after fifteen (15) days posting in three (3) conspicuous places of this municipality.


