MUNICIPAL ORDINANCE NO. 21-50

AN ORDINANCE ALLOWING NEW TRAFFIC SCHEME OF THE MUNICIPALITY OF POLANCO, ZAMBOANGA DEL NORTE.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF POLANCO, ZAMBOANGA DEL NORTE, IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE – This Ordinance shall be known and referred to as “NEW TRAFFIC SCHEME OF THE MUNICIPALITY OF POLANCO, ZAMBOANGA DEL NORTE”.

SECTION 2. COVERAGE – All motorists, residents and non- residents, passing through the streets of MUNICIPALITY OF POLANCO are required to obey this new Municipal Traffic Scheme.

SECTION 3. THE NEW TRAFFIC SCHEME:

- A.) All vehicles from the municipality of Sergio Osmeña and Poblacion Polanco bound for Dipolog should not be allowed to exit at Romero and Balintawak Streets but have to turn left at Macapagal Street and exit towards Bonifacio Street (National Highway) using Ocupe St. or 8 de Diciembre St. as their exit points.
- B.) All vehicles from Osmeña municipality and Poblacion Polanco bound to the municipality of Piñan will exit using Romero St. or Balintawak St. and Bonifacio St. (National Highway) as exit points.
- C.) All vehicles from Piñan bound for Poblacion Polanco or the Municipality of Sergio Osmeña should use Romero St. or Balintawak St. as their entrance point going to their destination. All vehicles bound to Dipolog should go straight using Bonifacio St.

D.) All vehicles from Dipolog bound for Poblacion Polanco and the municipality of Sergio Osmeña should use 8 de Diciembre as entry point except during Friday (Tabu Day) when 8 de Diciembre is closed for traffic.

Vehicles then should turn left to Macapagal St. then turn right to Balintawak St. then turn left to Mi Ultimo Adios St. then turn right to Jose Rizal St. to their destination.

Vehicles bound to Piñan should go straight using Bonifacio Street.

SECTION 4. DEPUTATION – Authorized personnel to implement this Ordinance are:

- a. Punong Barangay Poblacion North and Poblacion South with the Tanods
- b. Barangay Kagawad Chair on Peace and Order
- c. Barangay Public Safety Officer(BPSO)

SECTION 5. Period of Implementaion - Implementation shall be on a 24/7 basis unless there is a need to suspend in particular areas only for reasons of emergencies like fire, calamities, disasters and fiesta or other special occasions, up to the last day of January, 2022.


SECTION 6. REPEALING CLAUSE – All ordinances, resolutions, executive orders, memorandum circulars and all other issuances or parts thereof which are inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE – If only for any reason, any provision of this Ordinance is declared invalid or unconstitutional, other parts or provisions hereof shall continue to be in full force and effect.


SECTION 8. EFFECTIVITY – This Ordinance shall take effect upon its approval and after posting of copies in the Municipal Hall and three (3) other conspicuous places in the Municipality.


